

### Context Trade Switzerland – Australia Facts and Figures

#### Australia imports from Switzerland

Australia imports from Switzerland was US\$2.76 Billion during 2018, according to the United Nations COMTRADE database on international trade. Australia imports from Switzerland - data, historical chart and statistics - was last updated on June of 2020.

| Organic chemicals                                | \$45.69M  | 2018 |
| Essential oils, perfumes, cosmetics, toileteries | \$34.39M  | 2018 |

Switzerland is one of the top investors in Australia, typically the second or third largest investor out of Europe and always in the top 10.








### Context Swiss Presence in Australia
